I. IDENTITY OF RESPONDENT

Everett Public Schools (“the District”) is a Washington public school district located in Snohomish County, Washington. On January 3, 2020, it received a request in its public records office from the Freedom Foundation, seeking the following for each current Everett School District employee who is a member of a union-represented bargaining unit:

1. First name
2. Middle name
3. Last name
4. Work email address
5. Day and month of birth (excluding year).
6. Bargaining unit indicator, including any or all of the following:
 - a. Name of the entity recognized as the exclusive bargaining representative
 - b. The Public Employment Relations Commission decision number defining the bargaining unit
 - c. Other descriptor used by Everett School District to identify the bargaining unit.

On January 10, 2020, the District was served with a Summons and Complaint for Injunctive Relief in this matter, in which it was named as one of numerous defendants. The District has been participating in this litigation since that date.


II. RESPONSE TO PETITION


