This Court should disregard petitioner's purported first and second "Statement of Additional Authorities" because they are an improper use of RAP 10.8 to circumvent the rules governing petitions for review, which do not contemplate a reply in support of a petition. Respondent did not raise any new issues in his answer, so

RAP 13.4(d) prohibits a reply. Alternatively, they are a transparent attempt to evade the 5,000-word limit for petitions for review under RAP 18.17(c)(10). The "additional authorities" provided by petitioner are not new, as they all predate 2017. They could have been addressed in her petition, filed December 27, 2023, but presumably were not as they would have caused her 4,992-word petition to be overlength.

Even if a Statement of Additional Authorities containing cases that could have been addressed in the initial petition was appropriate, petitioner's filing of two separate statements to address the same issue (whether a beneficiary interest in a trust is property or an economic circumstance under the dissolution statutes) is inappropriate. Nothing in RAP 10.8 suggests that a party can file multiple statements of up to 350 words providing argument on additional authorities.

For these reasons, this Court should disregard petitioner's first and second Statements of Additional Authorities and should signal that it has done so in its order denying further review. Petitioner's experienced appellate counsel should be discouraged from misusing RAP 10.8 to provide "additional" authority that is not new and that has the consequence of evading the word count governing petitions for review.
