STATEMENT OF ADDITIONAL  
GROUNDS FOR REVIEW

I, Jeremy BAKKE, have received and reviewed the opening brief prepared by my attorney. Summarized below are the additional grounds for review that are not addressed in that brief. I understand the Court will review this Statement of Additional Grounds for Review when my appeal is considered on the merits.

Additional Ground 1

THAT OFFICER TOPAUM DIDN'T GO TO THE HOSPITAL TO MAKE A REPORT OF THE ASSAULT AND OFFICER TOPAUM DID NOT TAKE NO PHOTOS OF A BLOW OR A RED MARK ON HIS ARM TO PROVE THAT A ASSAULT HAD HAPPEN. ON PAGE 195 OF THE TRANSCRIPTS HE EVER SAYS HE DID NOT GET CHECKED OUT Y DIDNT BE GET IT CHECKED OUT HE SAID IT WAS DISLOCATED ON PAGE 193 LINE 8 OF THE TRANSCRIPTS ON PAGE 207 LINE 15-22 TELLS IT SELF THAT HE WAS NOT HURT BY NOT GETTING MEDICAL ATTENTION AND HE FINISHED HIS SHIFT THAT NIGHT THAT HE HAD 6 HOURS LEFT.

Additional Ground 2

TO PROVE THAT A ASSAULT HAD HAPPEN YOU MUST HAVE EVIDENCE THAT THE ASSAULT HAD HAPPEN LIKE A PHOTO OF THE ASSAULT, A HOSPITAL REPORT A WITNESS OFFICER TOPAUM HAD NONE OF THIS FOR EVIDENCE THE ONLY THING HE HAD WAS THAT HE SAID I KICKED HIM THIS IS HEARSAY. WITHOUT EVIDENCE TO PROVE THAT THE ASSAULT HAD HAPPEN I ASK THE COURT TO REVERSE THE CHARGE OF ASSAULT-3 OR GIVE ME A VERDICTIAL TO PROVE THIS DIDNT HAPPEN.
