
Pursuant to RAP 18.8, Petitioner Joshua J. Woolcott submits the following statement of additional authorities:



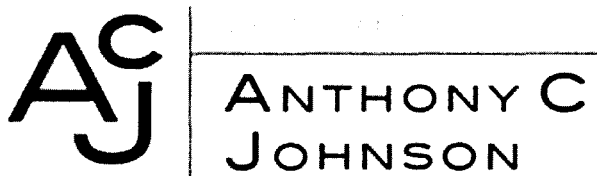
