Appellant George Artem has filed a petition for discretionary review in the above case. Mr. Artem has already sought direct review from this Court regarding the original King County Superior Court decision, brought a motion on the merits, and brought a motion for en banc hearing after the motion on the merits was denied by Commissioner Michael Johnston. This Court denied review and transferred the case to the Division I Court of Appeals. The Court of Appeals affirmed and now Mr. Artem is seeking discretionary review without making any colorable arguments with regard to the applicability of the RAP 13.4(b) factors. King County has already submitted extensive briefing on this matter and, unless directed to respond by the Court, will not be submitting any additional briefing with regard to Mr. Artem's most recent request for review.
