Pursuant to RCW 9.94A.664(4)(c), the court imposes a term of total confinement equal to one-half the midpoint of the standard range followed by a term of 12 months of community custody under RCW 9.94A.701, unless community custody is not authorized

for the original crime(s). As required by RCW 9.94A.664, the Department of Corrections (DOC) shall, within available resources, make substance use disorder assessments and treatment services available to the offender during the term of total confinement and subsequent term of community custody.
