

Michael,

I hope you are well and still able to travel to and from New York.

I am following up on the Andrews estate. I still owe you some information before we can mediate,. Namely, the invoices. I hope to provide those soon. I think you were also going to request dates from Jan Armstrong in the meantime.

With regard to some of the information requested in your letter, we have been unable to establish estate ownership of any vehicles. I was not aware of a few of the listed vehicles, but know that the Focus and the Oldsmobile were transferred prior to the passing of Lawrence Andrews. To this end, any mediation must be a global mediation with all heirs involved. Thus, it will be somewhat difficult from a logistical standpoint. Still, I presume Mr. Andrews will be able to raise his concerns with siblings who received the vehicles.

Similarly, we have no way of tracking the potential theft of \$28,000. I believe Ricky will probably say Vicki took it. Before Mr. May was appointed, Ricky Andrews was the Personal Representative. The money was not in the safe by the time Mr. May took over the estate. The theft, if any, may have occurred before Mr. Lawrence Andrews passed away.

The upholstery has been ruled upon. That is what Ricky is trying to appeal currently. I know you do not represent him in the appeal, but we will insist that the upholstery issue be dropped. In short, many upholstery shops were contacted, and nobody wanted it. Ricky could have taken the upholstery when he had the ability to pick items prior to the estate sale, and he did not. Also, had he offered \$5,000, it would have been accepted in an instant. He needs to let this go if he wants this matter resolved.

Regarding the house, Ricky offered no more than \$100,000. In fact, we had offered it to him at that price and waited months, but he was never able to tender payment.

Ricky did receive a distribution. It was the distribution to him that created an uproar amongst the other heirs. So, additional distributions were made.

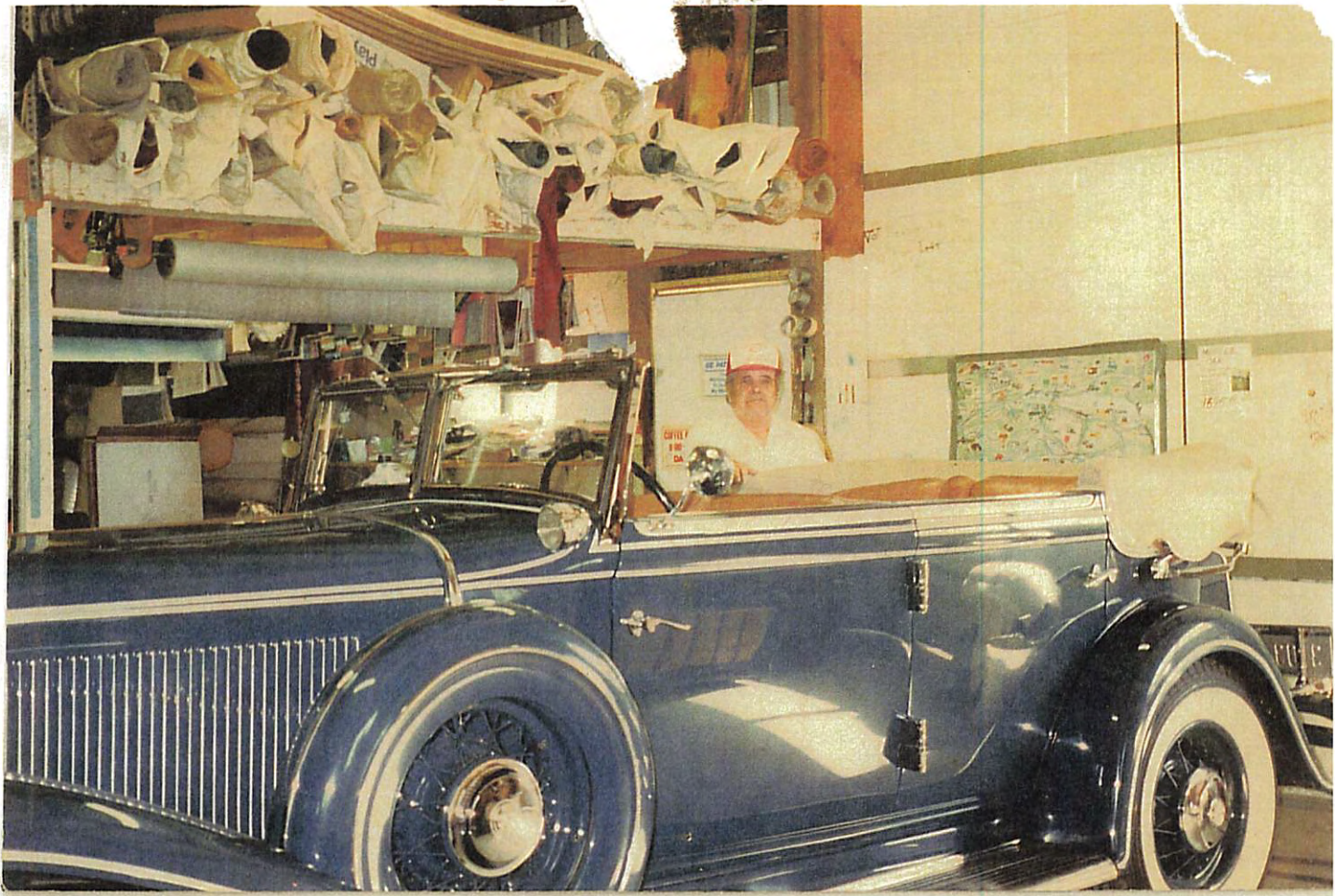
I will send along invoices, and look forward to hearing about dates.
