I. IDENTITY OF MOVING PARTY

II. STATEMENT OF RELIEF SOUGHT.

Larry D. Riley requests an extension of time to file the Appellant’s Petition for Review to the time on which it is actually accepted as filed; it was received by the Court on May 18, 2017 at approximately 5:04 PM, but stamped as received the following morning, May 19, 2017.

III. FACTS RELEVANT TO MOTION

The details of the problems of attempting to send the Petition through the Portal and its ultimate transmission are contained in the Declaration of Christine Tracy in Support of Motion for Extension of Time to File Petition for Review, and accompanying exhibits, all of which accompany this motion.

To summarize, Larry D. Riley, by and through his attorney, James L. Sellers, attempted to file the Petition for Review through the Court’s Portal and the JIS-Link, starting at 4:42 PM on May 18, 2017, within the 30-day period required to file the Petition. A legal assistant with experience filing through the Portal made approximately 25 attempts to send the Petition between 4:42 PM and 4:53 PM. In each instance, either an error message was shown on the Portal path or the attempts were knocked off the path to the Portal and the filer returned to the Court’s web site.

1 When a message instructed calling the site administrator was
2 shown, the legal assistant for Sellers Law Office who had been trying to
3 connect to the Portal contacted the Court by phone to see what could be
4 done. This assistant was informed in the phone call that the Court had
5 been having problems with the Portal and that an attempt would be made
6 to obtain permission for the legal assistant to email the Petition. The legal
7 assistant was put on hold while the person at the Court attempted to obtain
8 permission for the legal assistant to email the Petition for Review. When
9 approval to email was given, the assistant was first able to send the email
10 at 5:04 PM.

11 12 **IV. GROUNDS FOR RELIEF AND ARGUMENT**

13 The rule permitting this extension of time is RAP 18.8(b).
14 Extensions are granted “only in extraordinary circumstances and to
15 prevent a gross miscarriage of justice”.

16
17 In *Reichelt v. Raymark Industries, Inc.*, 52 Wn. App 763, 764 P.2d
18 653 (1988), after noting that this rigorous test has rarely been satisfied, the
19 court summarized cases in which it had been met:

20 In each of those cases, the moving party actually filed the notice of
21 appeal within the 30-day period but some aspect of the filing was
22 challenged. See *Weeks v. Chief of Wash. State Patrol*, 96_Wash. 2d
23 893, 895-96, 639_P.2d_732 (1982), notice *timely* filed, but filed in
24 wrong court; *State v. Ashbaugh*, 90_Wash. 2d_432, 438, 583_P.2d
1206 (1978), notice *timely* filed but rejected by court for lack of
filing fee; *Structurals Northwest, Ltd. v. Fifth & Park Place*,

1 *Inc.*, 33_Wash. App. 710, 714, 658 P.2d 679 (1983),
2 notice *timely* when filed within 30 days of entry of stipulated
3 "amended" judgment. In each case, the defective filings were
4 upheld due to "extraordinary circumstances", *i.e.*, circumstances
5 wherein the filing, despite reasonable diligence, was defective due
6 to excusable error or circumstances beyond the party's control. In
7 such a case, *766 the lost opportunity to appeal would constitute a
8 gross miscarriage of justice because of the appellant's reasonably
9 diligent conduct. RAP 18.8(b).

10 In the *Riley v Iron Gate* case before this Court, Mr. Riley actually
11 filed within the 30-day period, but some aspect of the filing was a problem
12 as in the cited cases. Mr. Riley's filing through the Portal was commenced
13 in sufficient time to conclude it, but there were problems with the Portal
14 that prevented his transmission of his Petition for Review after
15 approximately 25 attempts. A legal assistant at the Sellers Law Office
16 sought help from the Court on the phone with a person where the filing
17 had to be made, who sought out permission to email the Petition while the
18 legal assistant was put on hold. When the Petition could be finally filed, it
19 was four minutes late. In other words, the defective filing was due to
20 "extraordinary circumstances", *i.e.*, circumstances wherein the filing,
21 despite reasonable diligence, was defective due to excusable error or
22 circumstances beyond Mr. Riley's control.

23 If the extension is not granted the lost opportunity to petition the
24 Supreme Court for review would constitute a gross miscarriage of just

1 because of Mr. Riley reasonably diligent conduct or excusable error, like
2 in the cited cases.

3
4 **V. CONCLUSION**

5 For the reasons described above, Larry D. Riley respectfully
6 requests this Court to grant his Motion for Extension of Time to File the
7 Petition for Review.

1 (2) On May 18, 2017, I was employed as a legal assistant for
2 Attorney James L. Sellers in Vancouver, Washington, who is the attorney of
record for the Appellant herein.

3 (3) On that date, I was told by Mr. Sellers that I would be filing a
4 Petition for Review for Mr. Riley with the Supreme Court. I knew that it would
5 probably be ready for transmission through the Court's Portal later in the
6 afternoon. My familiarity with the Portal was the result of filings made by me in
7 the Court of Appeals, Division II, on this case. A true and correct copy of the
8 history from my computer, collected in the ordinary course of business with Mr.
9 Sellers, of my efforts to transmit the Petition for Review to the Court is attached
as Exhibit "A".

10 (4) At approximately 2:45 PM I started the Portal log-in process by
11 going to Washington State Courts and going through the steps, such as putting in
my user name and password in order to get things ready to scan and upload the
12 Petition for Review when the document was ready to send to the Court through
13 the Portal. I don't remember what paths I actually took to log in. I had never had
14 problems logging in through this system. When I had gone through the steps, I
15 thought from my experience with the log in that when I came back to transmit the
16 Petition for Review that the system would be ready for me to transmit the
17 Petition. I was called away until Mr. Sellers could give me the Petition to scan
and transmit.

18 (5) Mr. Sellers brought me the ready-to-go Petition shortly before
19 4:42 PM so that I could scan it and transmit it through the Portal. Although my
20 letter of May 24, 2017 that I sent to Ms. Armstrong (attached as Exhibit "B"),
21 which references the other exhibits to this Declaration, as well as other
22 documents that were also sent) states that Mr. Sellers gave me the Petition at 4:42
23 PM, I believe that it was actually shortly before 4:42 PM when I got it because I
had to scan the Petition when he gave it to me, and the history of this transaction
24 from my internet record (Exhibit "A") on my computer showed that I was

1 actually attempting to connect at 4:42 PM. When I returned to my computer to
2 make the transmission at 4:42 PM, I realized that I was not logged on the Portal.
3 Until that time, I assumed that I had been connected to the Portal and logged in.

4 (6) When I tried to connect at 4:42 PM, I kept getting error
5 messages to the Portal and was being knocked off the path through JIS-Link (and
6 returning me to the Court's web site).

7 (7) I tried connecting through the Odyssey Portal and JIL-Link, but
8 nothing would let me in. Then I received a message on my computer to call the
9 site administrator. I began to panic and gave up attempting to transmit through
10 the Portal at 4:53 PM and called the Supreme Court Clerk's office. I had tried to
11 get on the Portal and JIS-Link 25 times in eleven minutes, when I explained to a
12 woman on the phone at the Supreme Court that I was having trouble and needed
13 to file a Petition for Review that day and wanted to know what they thought I
14 should do. She commented to me that they had been having problems with the
15 Portal that day.

16 (8) I recall and believe that the woman on the phone was named
17 Joslyn, but I'm not completely sure. She told me that she was going to have to
18 go ask someone if I could email the Petition. She put me on hold for at least a
19 couple minutes. When she came back, she told me that I could email the Petition
20 in for filing and gave me the email address. She said she would stand there and
21 wait for it and stamp the Petition when it came in. I thanked her and we hung up.
22 I then emailed the Petition to *supreme@courts.wa.gov* which my computer email
23 history shows was sent at 5:04 PM. I wasn't sure if it went through, as I was in a

1 panic, so I emailed it again; my computer email history shows that it was sent for
2 the second time at 5:11 pm. From 4:42 PM until my last email, I had been
3 frantically engaged in attempting to send the Petition.


4 (9) I printed and enclosed a copy of my history from my internet
5 server for May 18, 2017, which shows when I was trying to log on to the Portal
6 and JIS-link at 2:44 pm and again at 4:42 pm until I gave up at 4:53 pm and
7 called the Court and got permission to email the Petition. I have also
8 enclosed the copies of my two emails that I sent, each with a copy of the
9 Petition for Review, which are attached as Exhibit "C" & "D".

10 (10) At no time prior to my attempting to transmit the Petition
11 did I have any inkling that the Court had been having any problem with its
12 Portal, or that I would have a problem accessing it myself.

13 (11) I also emailed the Petition for Review on May 18, 2017 to
14 opposing counsel, which had authorized service of the Petition by email.
15 Exhibit "E" is the Declaration of Service.

16 (12) The filing fee was mailed to the Court along with the
17 mailed copy of my letter and the other documents.

I printed and enclosed a copy of my history from my internet for May 18, 2017, which shows when I was trying to log on to the Portal and JIS-link at 2:44 pm and again at 4:42 pm until I gave up at 4:53 pm and called getting the email address. I have also enclosed the two copies of my emails that I sent the *Petition of Review*.

Please notify us if we have not provided adequate documentation and need to make a *Motion for an Extension*.

Mr. Sellers requested I send you a copy of the Declaration of Service that I emailed Mr. Xochihua the *Petition of Review* on May 18, 2017. Mr. Xochihua had previously agreed to accept service by email.

I have also enclosed our check no. 2994 for \$200.00 for the filing fee.


