REVISED STATEMENT OF  
ADDITIONAL AUTHORITIES

(RAP 10.8)

Corey Irish, the Appellant, acting pro se, hereby submits the following revised statement of additional authorities:

1. State v. Cann, 92 Wn.2d 193, 197, 565 P.2d 912 (1979).
2. State v. Danforth, 97 Wn.2d 255, 257-58, 643 P.2d 882 (1982).
3. State v. Smeltzer, 86 Wn.App. 813, 820, 939 P.2d 1235 (1997).
4. State v. Thomas, 139 Wn.App. 1065, P.3d (2007).
5. State v. Walls, 81 Wn.2d 518, 503 P.2d 1068 (1972).

The above cases support the arguments made by Irish in his Petition for Review (PFR) because:

In Irish's PFR, he incorporates by reference therein arguments from his Motion for Reconsideration (MFR) that are material to his PFR argument C. (5). PFR at 11. In his PFR, Irish argues that the Court of Appeals (COA) "should be required to make an independent determination as to whether Irish's Carle issue is double jeopardy." Id.

And in his MFR, Irish argues numerous cases to demonstrate that his Carle issue is not double jeopardy, urging the COA to render such a determination distinguishing them. So the additional authorities provided herein support Irish's PFR and MFR arguments that "Specific vs. General" and "Double Jeopardy" are not the same and require different tests.

The additional authority most illustrative of Irish's previous arguments is Thomas, in which the COA conducts independent tests for "Double Jeopardy" and "Specific vs. General".
