Respondents City of Seattle, Seattle Police Department, Courtney Love Cobain and Frances Bean Cobain oppose Appellant Richard Lee's Motion for Extension of Time to file his Omnibus Reply to Answer to [sic] Petition for Review, and move to strike said Omnibus Reply filed on September 24, 2018.

RAP 13.4(d) provides that "[a] party may file a reply to an answer only if the answering party seeks review of issues not raised in the petition for review."
