SUBJECT: 2014 Summary of Changes to Antiharassment Protection Order Forms

The Washington Pattern Forms Committee updated the Antiharassment Protection Order forms to implement:

- Laws of 2014, Ch. 111, Relating to Surrender of Weapons
- Recommended changes from the legal community

Detailed descriptions of the changes follow:

1.	UHST 2.025	Worksheet for the Harassment and Stalking Petition  This form was substantially revised. Please discard the previous version and replace it with the June 2014 version.
2.	UHST 2.020	Petition for an Order for Protection – Harassment/Stalking  This form was substantially revised. Please discard the previous version and replace it with the June 2014 version.
3.	UHST 5.010	Petition for an Order for Protection – Respondent Under Age 18 - Harassment/Stalking  This form was substantially revised. Please discard the previous version and replace it with the June 2014 version.
4.	UH 3.020	Temporary Protection Order and Notice of Hearing – Harassment  On page one and two, change the restraint provisions as follows:  First restraint: delete “1)” to the left of the check box. To the right of the check box, insert “ <b>No-Contact.</b> ” change respondent to lower case “r”.

		<p>Second restraint: delete “2)” to the left of the check box. To the right of the check box, insert “<b>Surveillance:</b>” change respondent to lower case “r”.</p> <p>Third restraint: delete “3)” to the left of the check box. To the right of the check box, insert “<b>No-Contact:</b>” change respondent to lower case “r”.</p> <p>Second restraint: delete “2)” to the left of the check box. To the right of the check box, insert “<b>Surveillance:</b>” change respondent to lower case “r”.</p> <p>Third restraint: delete “3)” to the left of the check box. To the right of the check box, insert “<b>Stay Away:</b>” change respondent to lower case “r”.</p> <p>Fourth restraint: delete “4)” to the left of the check box for “<b>Other.</b>”</p> <p>Fifth restraint: delete “5)” to the left of the check box. To the right of the check box, insert “<b>No-Contact:</b>” change respondent to lower case “r”.</p> <p>Second restraint: delete “2)” to the left of the check box. 		<p>insert and center a new heading "Service."</p> <p>At the end of the form, change the box regarding the "(LEIS)" as follows:</p> <p style="text-align: center;"><b><u>Petitioner or petitioner's lawyer must complete a Law Enforcement Information Sheet (LEIS) and include addresses for the respondent and respondent's guardian.</u></b></p>
