## 3. Restraining order

#### 4. Requests

I ask the court to:

- Deny** the Petition because (check all that apply):
- The current legal parents should be confirmed as the legal parents.
    - Genetic testing should not be done because it is not in the children’s best interests.
    - Genetic testing has already been done that proves the current legal parents are the genetic parents.
  - The case was started after the deadline. The *Petition* was first filed or served more than four years after:
    - The date a Court decided who the children’s legal parents were, or
    - The date a *Paternity Acknowledgement* was filed (or the child’s birthdate, if the child was born after the *Paternity Acknowledgement* was filed).
  - The Petitioner has no right to bring this case because s/he either:
    - Was included as a party in a court case that already decided the children’s parentage; or
    - Signed a *Paternity Acknowledgment* or *Denial of Paternity* for the children.
- Sexual Assault**
- See the requests listed in the *Sexual Assault Allegation* (FL Parentage 365) filed separately.

- Appoint a Guardian ad Litem (GAL) to make investigate and make recommendations to the court about whether genetic testing should be done.
