A Note on Appointment and Election of Judges

<u>Federal Court judges</u> (except magistrate judges) are appointed by the President, with advice and consent of the Senate, for life. During their tenure they serve as active judges, or may take senior status or retire. All judicial positions are non-partisan.

<u>Washington State judges</u> (Superior and Appellate courts) are either elected for specified terms or appointed by the Governor (to fill a vacancy) to serve until the next general election in which case they must stand for election by the voting public. Similarly, County District Court judges are either elected for specified terms or appointed by the County Commissioners to serve until the next general election; and Seattle Municipal Court judges are either elected for specified terms or appointed by the Mayor and City Council to serve until the next general election. All judicial positions are non-partisan.
