#### NATIONAL WOMEN'S HISTORY MONTH

March was National Women's History Month, and this year marks the 30th anniversary of both the establishment of Women's History Week, which later became Women's History Month, and the beginning of the National Women's History Project. #### CHIEF JUSTICE BARBARA A. MADSEN

Justice Barbara A. Madsen has become the 55th Chief Justice of the Washington State Supreme Court, succeeding its longest serving Chief Justice, Justice Gerry L. Alexander. When she was first elected to the Supreme Court in 1992, Justice Madsen became the third woman to serve on the court. She was re-elected in 1998 and in 2004. Chief Justice Madsen also Chairs the Washington State Gender and Justice Commission. On March 25, 2010, Justice Madsen was honored as the "2010 Woman of the Year" by the Seattle University School of Law Women's Law Caucus.

#### Justice Sotomayor and the Washington Bench

The addition of Justice Sonia Sotomayor to the US Supreme Court prompted reflections on the underrepresentation of Latinos in Washington State's judiciary in an article by the past president of the Latino/a Bar Association of Washington, Nicole McGrath, in the January, 2010, edition of the Washington State Bar News. In "Fair and Diverse Judicial Representation", McGrath states that among more than 400 Supreme Court, Court of Appeals, superior court, district court and municipal court judges in Washington, only six, consisting of two superior court judges and four municipal court judges, are of Latino/a heritage.

The article, which includes a conversation by the author with Washington's most prominent Latino jurist, retired state Supreme Court Justice Charles Z. Smith, concludes with this observation: "We celebrate Justice Sotomayor's appointment and our own extraordinary judges of color, but our celebration must be tempered with the commitment to do more to diversify the bench in Washington State. Our court system needs to reflect the community it serves...."

#### FIFTH ANNUAL STATEWIDE DIVERSITY CONFERENCE

The Seattle University School of Law will host the Fifth Annual Statewide Diversity Conference, a Washington Minority Bar Associations Collaboration Project. The daylong Conference is scheduled for Friday, June 25, 2010, beginning at 8:00 a.m. at the Seattle University School of Law, Sullivan Hall.

Since 2006, Washington's minority bar associations have collaborated to present an annual statewide diversity conference for Washington lawyers, law students, and legal professionals. Previous conferences have addressed topics such as: developing expertise in new areas; opportunities to impact public policy; addressing bias/stereotypes in negotiations, mediations, and client meetings; and how to retain diversity and keep your practice profitable in an economic downturn. The

Gonzaga University School of Law hosted the fall business meeting of the American Bar Association's Presidential Advisory Council on Diversity in conjunction with its annual "Building Bridges Week" in October 2009.

The week included "The Color of Justice," a full day forum on careers in the justice system attended by 75 high school students and numerous justice system professionals from the Spokane area. The day began with a welcoming address by a video greeting from Governor Christine Gregoire and speech by Bruce Hawkins, Superintendant, Educational Service District 123.

The forum was co-sponsored by Gear Up, Washington State Gender and Justice the Commission, and the Washington State Minority and Justice Commission. At a reception concluding the day, Carl Maxey Diversity Scholarships were awarded to two Gonzaga law students. The annual scholarships, named in honor of the late Carl Maxey, a Gonzaga Law School graduate and prominent member of the Washington State and Spokane County Bar Associations, are awarded by the Spokane County Bar Association's Diversity Section. #### TRI-CITIES YOUTH AND JUSTICE FORUM

The 7th annual Tri-Cities Youth and Justice Forum, held at Columbia Basin College in November 2009, brought together approximately 200 8th through 12th grade students from schools throughout southeast Washington. In addition, approximately 60 volunteer professionals, including judges, law enforcement officers, K-9 teams, attorneys, corrections officers, court interpreters, juvenile probation counselors, court clerks, educators, court reporters, forensic scientists, and others attended.

The forum, initiated in part under the auspices of the Washington State Minority and Justice Commission and for which the Commission continues as a co-sponsor, promotes racial and ethnic diversity in

the justice system workforce by encouraging students, including those of color or from other communities historically underrepresented among justice system professionals, to pursue those professions.

Direct interactions between students and professionals in discussion groups, games, skits, and a mock trial: stimulate the students to think about and understand both their legal rights and obligations as members of their communities, and encourage the students to learn about and consider opportunities for careers in the justice system.

The forum is co-sponsored or otherwise supported by the Washington State Minority and Justice Commission, Educational Service District 123, Columbia Basin Community College, the Young Lawyers' section of the Washington State Bar Association, the Latina/o Bar Association of Washington, Benton-Franklin Counties Superior Court, the Benton-Franklin Counties Bar Association, and numerous local businesses.

The newest minority bar association in Washington, the Middle Eastern Legal Association of Washington (MELAW) celebrated its first year of existence in February. #### OREGON CHIEF JUSTICE ADDRESSES LATINA/O BAR ASSOCIATION OF WASHINGTON

The Latina/o Bar Association of Washington (LBAW) held its 18th annual awards and fundraising dinner with the theme, "The Power to Serve" on January 29, 2010. Oregon Chief Justice Paul De Muniz, the first Latino to serve on the Oregon Supreme Court, was the keynote speaker.

Chief Justice De Muniz began his judicial career, servicing for ten years on the Oregon Court of Appeals. He joined the Oregon Supreme Court in January 2001 and became Oregon's 41st Chief Justice in January 2006. In 2008, Chief Justice De Muniz was elected to the Board of Directors of the Conference of Chief Justices and is one of eight state chief justices to participate in a three-year Harvard University study of the role of state court leaders.

Chief Justice De Muniz served on the Oregon Judicial Fitness and Disability Commission, the Oregon Supreme Court Access to Justice for All Committee, and chaired the Committee to Implement Recommendations made by the Oregon Supreme Court Task Force on Racial/Ethnic Issues in the Judicial System. Chief Justice De Muniz was born in Glendale, California and grew up in Portland, Oregon. He graduated from Portland State University in 1972 and Willamette University College of Law in 1975.
