1. That I am over the age of 21 years, a citizen of  
the United States, and currently residing in the State of  
Minnesota, and I am competent to testify if so required;

2. That I am currently incarcerated in a  
Corrections Corporation of America (CCA) facility called  
Prairie Correctional Facility (PCF), Box 500, Appleton,  
MN 56208, pursuant to a Judgment and Sentence of the  
State of Washington and under the custody and supervision  
of the Washington State Department of Corrections

1 Secretary Eldon Vail;

2 3. The Petitioner is a seasonal worker in Alaska  
3 working for Peter Pan Seafoods, Inc. from the time period  
4 of January 2000 until the time of his arrest;

5 4. The Petitioner was initially assigned Victoria  
6 Freer as his court appointed defense counsel;

7 5. The Petitioner in defense of the alleged charges  
8 asserted to his defense counsel that he was innocent and  
9 that information by way of his work history would show  
10 his innocence; APPENDIX #1 Petitioner's Work History

11 6. The defense counsel upon the Petitioner's  
12 insistence requested the Petitioner's work history from  
13 the Petitioner's employer; APPENDIX #2 Letter

14 7. On April 14, 2005, Peter Pan Seafoods, Inc.,  
15 sent the Petitioner's work history for the time period of  
16 January 2000 through October 2004;

17 8. The Petitioner was never notified of defense  
18 counsel's receipt of this information or provided a copy;


