STATEMENT OF ADDITIONAL
GROUNDS FOR REVIEW

I, Floyd W. Drane, have received and reviewed the opening brief prepared by my attorney. Summarized below are the additional grounds for review that are not addressed in that brief. I understand the Court will review this Statement of Additional Grounds for Review when my appeal is considered on the merits.

Additional Ground 1

Both alleged victims MS. MATTERN and MS. JACQUES WAS INCARCERATED IN PIERCE COUNTY JAIL, DURING THEIR PERIOD OF INCARCERATION MS. MATTERN AND MS. JACQUES SHARED THE SAME CELL FOR SEVERAL DAYS HAVING AMPLE TIME TO CORROBORATE WITH EACH OTHERS CONCERNING THE CASE. RP 239. THE RECORD WILL REFLECT THAT THERE WAS NO PERMANENT DISFIGUREMENT OF MS. MATTERN. THERE WERE SEVERAL CHANGES MADE IN THE COURT RECORDS TO SUPPORT THAT THERE WAS NO PERMANENT DISFIGUREMENT, IN THE FINAL FINDING OF FACTS.

Additional Ground 2




