STATEMENT OF ADDITIONAL
GROUNDS FOR REVIEW

I, WILLIAM A. BARGE, have received and reviewed the opening brief prepared by my attorney. Summarized below are the additional grounds for review that are not addressed in that brief. I understand the Court will review this Statement of Additional Grounds for Review when my appeal is considered on the merits.

HIT AND RUN INJURY - Additional Ground 1

THERE WAS TESTIMONY OF ME, THE DEFENDANT, PASSING 30 PARKING SPACES, AFTER THE COLLISION FROM THE OFFICER. THE PARKING LOT WAS 13 SPACES ON THE LEFT AND 11 ON THE RIGHT. 
