STATEMENT OF ADDITIONAL
GROUND FOR REVIEW

I, David Gibson, have received and reviewed the opening brief prepared by my attorney. Summarized below are the additional grounds for review that are not addressed in that brief. I understand the Court will review this Statement of Additional Grounds for Review when my appeal is considered on the merits.

Additional Ground 1

I feel that the Pierce County Sheriffs were at the residence on false pretense. They perjured them-selves by saying that they were there looking for Kenneth Lyndell to serve out a warrant. The Pierce County Sheriffs office had already arrested Kenneth Lendell and per. a court order had been sent to Western State hospital. He was at Western State at the time of my arrest.

Additional Ground 2

I feel that the Pierce County Sheriffs department over-stepped their authority when they placed me under arrest on a non-extraditable King County warrant. It is my understanding that a non-extraditable warrant can only be served within the county it is placed. Otherwise it would be a state wide warrant. Since I was in Pierce County they could not arrest me on such a warrant. I believe that I was arrest on a non-extraditable warrant so the Sheriffs dept. could conduct a warrant less search and seizure.
