STATEMENT OF ADDITIONAL  
GROUNDS FOR REVIEW

I, GERALD H. KANG, have received and reviewed the opening brief prepared by my attorney. Summarized below are the additional grounds for review that are not addressed in that brief. I understand the Court will review this Statement of Additional Grounds for Review when my appeal is considered on the merits.

Additional Ground 1

Court 1 - Washington State Police Officers said the video on "Limewire" is not erasable. This video came from the inoperable desktop computer seized during police search of my residence. However, when completing my research of computer networking studying "Limewire", I erased "Limewire" before the computer became inoperable. Would like to add, unlike Google or Yahoo search engines, World Wide Networking, "Limewire's" search engine requires downloading to view. Consequently, legal and illegal information are downloaded uncensored.

Additional Ground 2

The Court Appointed Attorney said, "he had 17 years experience." However, as court transcripts reveal, the court appointed legal counsel was incompetent and lacked litigation skills required to defend the defendant. The attorney was negligent in giving advice as well as legal consultation to his defendant. He admitted having no knowledge of computers except "how to play solitaire".
