## STATEMENT OF TYSON GREGG

There are many things I would like to make the court aware of. At my trial my juvenile record was unsealed and used as evidence against me. I believe that was improper and I am being punished a second time for the same offense.

Pam Noble is the alleged victims' biological mother. Pam Noble testified at my trial under oath as the custodial parent, when in fact, Robert Day, Pam Nobles' ex-husband, has been the custodial parent of the alleged victim, Ashley, since she was three years old. During her childhood, the alleged victims' mother, Pam Noble, resided in the state of Iowa. This brings up the question of how Pam Noble could testify to the alleged victims' state of mind during the alleged incidents.

Robert Day informed the prosecutors office that he was aware of discrepancies in the alleged victims' time line for the alleged incidents, but the prosecution neglected to inform the defence, which brings the rules of disclosure into question.

There were numerous witnesses that were not allowed to testify in my behalf under the guise of attacking the credibility and reputation of the alleged victim. These witnesses included, but are not limited to, Robert Day, the victims' father, Kay Day, my grandmother, Steve and Laurie Purviance, my parents, and some of my cousins. Conversely, my credibility and reputation, as well as my childhood were severely attacked by the prosecution.

It is my understanding that the jury was hung on two different occasions. Allegedly on the first occasion, the jury was instructed by the judge to go home for the evening and come back the next day and continue to deliberate until a verdict is reached. The court informed the defence of only one occasion when the jury was hung, thus we were not aware of the second occasion.

It should be noted that I attended high school with one of the jurors, namely Kandi Lemon. It is my belief that having a person on the jury that may or may not have a prejudice, could propagate impartiality that would affect the out come of their verdict.


My juvenile record was proselytized in a negative depiction. Without going into detail, I had successfully completed the SOSSA program, which included polygraph tests which I passed. Some of

of the polygraph tests were conducted during the same period of time that the alleged incidents occurred.

I would like to make note here that I was forced to reconstruct a five year period of my adolescent life in order to produce alibis for specific dates of alleged incidents. I would challenge anyone to remember where they were and what they were doing every day during a five year period of their adolescence, or for that matter, any five year period. However, as a past victim of sexual abuse myself, I can say that it is indelible in my memory as to what happened in infinite detail, and when it occurred. The alleged victim in this case can not remember the time line or the details of the alleged abuse to a period of time of less than five years.

I pray that the court will give me the opportunity to re-try this case so that the story in its entirety can be revealed. I thank you for your time and for listening to what I have to say.
