AFFIDAVIT IN SUPPORT OF:  
Statement of Additional Grounds

I, Karen Lofgren, declare under penalty of perjury under the laws of the State of Washington that the following is a true and correct statement to the best of my knowledge:

I understand there is very little case law on which I can ask you to remand my case for re-sentencing. I am however, asking for your mercy. I have read extensively on the subject of sentencing ranges. The literature explicitly states the low end of the standard sentencing range is for people who have no criminal history, and the high end is intended for those who do.

I pray you will recognize the mitigating circumstances which I believe Judge Stolz failed to consider. I hope you will read the letters in support of my character and clearly see as Dr. Mark Mays reported, this is an isolated, aberrant act, totally out of character. The transcripts of my sentencing hearing reflect Judge Stolz's hostility towards me. She denied me due process when she continued the no contact order with my children until they are 18 years old. They are my world and I was theirs. Judge Stolz had multiple letters to support this, yet she ruled against them and me.

Again, I ask for your mercy. Please remand my case for a more fair sentence and please let me see my children. Thank you.




