GROUNDS FOR REVIEW

Additional Ground 1

Per RCW 9A.020 the alleged crime is an Identity theft of the First Degree because the alleged victim, Ronald Brockman, is over 65 yo and disabled. However, the Jury found me NOT GUILTY in the Identity Theft of the First Degree. I am asking to discuss criminal charges on this ground.

Additional Ground 2

I am asking to cancel a fine of \$800.00 imposed by Pierce County Superior Court because this Court found me INNOCENT on the same day they imposed this fine (Attached correspondence).
