- Associated Indem. Corp. v. Del Guzzo, 195 Wash. 486, 509, 81 P.2d 516 (1938) ("fraudulent misrepresentation may be effected by half truths calculated to deceive");
- Attorney Grievance Com'n v. Floyd, 400 Md. 236, 251-53, 929 A.2d 61 (2007) (lawyer violated Maryland's RPC 8.4(c),
