1. I am the respondent in this matter. I make this financial declaration in support of my motion for fees and costs on appeal.
2. I am currently employed as a leasing and property manager in Redmond, WA.

For the trial court action to date, I have incurred \$73,649.28 in fees and costs to my trial attorney Cynthia Whitaker, \$6,913.56 of which is interest, and \$84,851.67 in fees and costs to my trial attorney Jerry Kimball, \$11,108.35 of which is interest. Although Mr. Bernard was ordered to pay \$59,480 of those fees, he has stayed enforcement of the judgment for fees. I have only been able to make nominal payments to my trial attorneys, and a balance of \$118,833.99 remains owing.

6. I was awarded \$37,250.86 in fees and costs by the Court of Appeals. Since then I have incurred \$19,939.17 in fees and costs in this action through the month of April 2008.

I declare under penalty of perjury under the laws of the State of Washington that the foregoing is true and correct.
