I am the attorney representing petitioner James Grantham in the above-captioned case. I write to clarify comments I made yesterday when discussing the record during oral argument. I may not have accurately explained the pleadings to which relevant documents are attached.


In my argument, I referred to "Appendix C" as containing the information that the Department of Corrections supplied Mr. Grantham regarding his ability to present witnesses, as opposed to documentary evidence, at the hearing. The hearing notice is Appendix C to Mr. Grantham's original personal restraint petition, which is titled Brief in Support of Personal Restraint Petition.

I also referred to appendices relating to Mr. Grantham's efforts to obtain documentary evidence to use at his disciplinary hearing. These documents are also attached to Mr. Grantham's Brief in Support of Personal Restraint Petition, as Appendix E and Appendix F.

Finally, I referred to the telephone records from October 2007. These records may be found in Appendix E of the Petitioner's Supplemental Brief, as well as Appendix B of the Amended Motion for Discretionary Review, filed in this Court.
