Pursuant to RAP 10.8, the Respondent Department of Corrections (Department) submits the following two additional authorities related to the issue of whether a sentencing court's waiver of costs of incarceration that may be imposed under RCW 9.94A.760(2) constitutes a waiver of costs of incarceration under RCW 72.09.111 and RCW 72.09.480:


(1) RCW 72.09.110. This statute states in relevant part:

All inmates working in prison industries shall participate in the cost of corrections, including costs to develop and implement correctional industries programs, by means of deductions from their gross wages.

(2) *Laws of 2011, ch. 282 §§ 1-3 (H.B.1334)*. This statute, signed into law by the Governor on May 5, 2011, adds a 20% deduction for "civil judgments for assault" to the list of deductions the Department makes under RCW 72.09.111 and RCW 72.09.480.


