Burr v. Branker, 2012 WL 1950444 (M.D. North Carolina) (United States District Court judge for the middle district of North Carolina granting habeas corpus relief to petitioner after finding that petitioner's right to effective assistance of trial counsel was violated and that state court's decision to the contrary was an unreasonable application of clearly established federal law, where trial counsel failed to investigate and prepare a defense based upon testimonial and medical evidence tending to show that fatal head injury of alleged victim was accidental and not the result of intentional child abuse and murder by petitioner).

Burr v. Branker, 2009 WL 1298116 (Order and Supplemental Recommendation of United States Magistrate Judge) (incorporated by reference in the above noted decision).
