The federal trial court held:

While the court can find no precedent for a motion requesting the reinstatement of maintenance and cure, it cannot ignore the controlling case law which dictates that claims for maintenance and cure are to be liberally construed. Accordingly, the motion to reinstate maintenance and cure will be granted.

Id., 1998 A.M.C. at 8 (emphasis aded).
