Pursuant to RAP 10.8, petitioner Todd McLaughlin submits the following additional authorities to the Court.

- *State v. Van Wolvelaere*, __ Wn.2d __, __ P.3d __, No. 97283-4 (April 30, 2020) (a snowmobile is a “motor vehicle” within the meaning of RCW 46.04.320(1) because it is “self-propelled,” unlike a bicycle, and capable of moving and transporting people or property on a public highway. The Court was careful to ensure that its analysis did not render other statutes “meaningless.” The Court has historically turned to statutory definitions rather than dictionaries when resolving questions about whether a particular class of vehicle is a “motor vehicle” under Washington law.).
