## **I. ISSUES**

(1) Police served a valid search warrant for business records. The business responded by providing some records that were not covered by the warrant. Based on these additional records, police obtained a broader search warrant. Did the seizure of evidence pursuant to this second search warrant constitute an unlawful search?

(2) Did the trial court abuse its discretion in admitting records of text messages, based on testimony from a records custodian that the messages were maintained in the ordinary course of the phone company's business?

## **II. STATEMENT OF THE CASE**

At around 6:00 a.m. on June 26, 2008, the defendant Debra Canady called police. She told them that she had come home and found her ex-boyfriend, David Grim, unconscious. The officer who responded found Grim dead on his bed. 2 RP 247-53.<sup>1</sup> His skull had been fractured by repeated blows with a blunt object. 7 RP 854-62. The marks left on the skull appeared to have been made by a drywall hammer. 7 RP 875-77.

The defendant had lived with Grim for around four years. In late 2007, she became romantically involved with Brent Starr. She tried to get Grim to move out of the house. He moved out for about two weeks but moved back in while she was gone. Starr sometimes spent the night with the defendant on the hide-a-bed in the living room, while Grim slept in the bedroom. By June, relationships between Grim and the defendant were "strained." 6 RP 726-29. The defendant was the beneficiary of insurance policies on Grim's life totaling \$287,500. 5 RP 551-54.

In their initial investigation of the murder, police questioned both Starr and the defendant. Starr said that the defendant had sent him text messages saying that she had found Grim dead. 3 RP 403. The defendant said that she had not told Starr about finding Grim's body. 3 RP 290.

Based on this information, police obtained a search warrant for Verizon's records of the defendant's and Starr's phone calls and text messages. The search warrant covered records from 6 a.m. to 12 p.m. on June 26, 2008. 1 CP 114. Det. Patrick VanderWeyst of the Snohomish County Sheriff's Office faxed a copy of the search warrant to Verizon. He also had a telephone conversation with a

Verizon representative, in which he specified the period covered by the warrant. 2 RP 192-94.

In response, the Verizon representative sent Det. VanderWeyst an e-mail with a file containing text messages. Det. VanderWeyst opened the file and started reading the messages. He found messages discussing the murder. He then realized that the file included messages preceding the period covered by the search warrant. 2 RP 196-99. According to the trial court's findings, "Neither Detective VanderWeyst nor any other law enforcement officer did anything to direct Verizon in any way to send records outside the scope of the warrant." 1 CP 42-43, finding no. 4. This finding has not been challenged.

Based on the information sent by Verizon, Det. VanderWeyst sought and obtained a second search warrant. This warrant covered the period from June 20 through July 3. 1 CP 131. Records obtained pursuant to this warrant were introduced at trial. Ex. 3.

In the text messages, the defendant and Starr discussed their plans:

[Canady to Starr 6/21/08 22:09:40] Lee is matchin me  
drink 4 drink. He thinks we r on our fourth and its our  
sixth! Doubles

[Starr to Canady 6/21/08 22:14:47] that's bad

[Canady to Starr 6/21/08 22:17:10] For me or him?  
Dave still at home. He has had two drinks.

[Starr to Canady 6/21/08 22:18:25] for him. ok he  
stayin home then. good.

...

[Starr to Canady 6/22/08 0:36:27] K the Russian  
family is awake and having a fire out side. cant go  
that way. to many people still awake around the  
house yet. have to wait a little longer

[Starr to Canady 6/22/08 0:36:29] K for people to  
crash. dave is asleep all lights off in the house.

[Starr to Canady 6/22/08 0:44:25] I didn't get what you  
sent me

[Starr to Canady 6/22/08 0:47:58] im horny, really  
horny.

[Starr to Canady 6/22/08 0:53:44] cant do it yet, to  
many people awake where I need to go. have to wait  
til every one has crashed

...

[Canady to Starr 6/25/08 11:54:49] I can buy oleander  
seeds on ebay but wont get here til next week. I keep  
lookin

...

[Starr to Canady 6/25/08 13:32:26] see if there is  
anything like most deadliest plants of Washington

[Canady to Starr 6/25/08 13:34:39] U know whn may  
have then is Mulbaks in Woodinville. I will call them.

[Starr to Canady 6/25/08 13:35:13] good thinking

During the early morning on June 26, Starr and the defendant exchanged the following messages:

[Starr to Candy 6/26/08 3:46:45] its done

[Starr to Canady 6/26/08 3:47:09] I need pants

[Canady to Starr 6/26/08 3:48:12] U comhng here?

[Starr to Canady 6/26/08 3:51:20] nevermind, I have a pair. have a great day. is messy in yr room, sorry.

[Canady to Starr 6/26/08 3:52:54] Was it quiet?

[Starr to Canady 6/26/08 3:53:24] mostly

[Starr to Canady 6/26/08 3:55:23] he though I was kev

[Canady to Starr 6/26/08 3:57:25] U may have to toss yr clothes if they come to question you

[Canady to Starr 6/26/08 3:57:29] U may have to toss yr clothes if they come to question you

[Canady to Starr 6/26/08 3:58:24] Erase yr phone

[Starr to Canady 6/26/08 4:05:39] I left the trailer at 345 ok

[Canady to Starr 6/26/08 4:06:07] K

[Starr to Canady 6/26/08 4:34:35] make sure u lock the door when u lreave please. love u baby.

[Canady to Starr 6/26/08 4:35:18] Love you too

An examination of the defendant's work computer verified that on June 25, she had done a search for "deadliest plants in Washington state." She had also searched e-Bay for oleander

plants. 6 RP 708-11. Oleander is one of the most poisonous plants known. Six or eight seeds would be lethal. 5 RP 610-11. The defendant's work computer had links to several nurseries, including Molbak's. 6 RP 709.

Canady was charged with first degree murder, committed while armed with a deadly weapon. 1CP 147. Starr was charged with the same crime. The two were tried jointly. The jury found both guilty as charged.<sup>2</sup> 1 CP 57-58.

### **III. ARGUMENT**

#### **A. THE DEFENDANT'S TEXT MESSAGES WERE OBTAINED PURSUANT TO A VALID SEARCH WARRANT.**

##### **1. Both The Fourth Amendment And Article 1, Section 7 Of The Washington Constitution Govern State Action, Not Private Conduct.**

Police obtained a search warrant for the defendant's text messages. The validity of this warrant has not been challenged. In responding to the warrant, phone company employees provided text messages outside the scope of the warrant. After viewing these messages, police used the information to obtain a second search warrant that specifically covered the additional messages.

The defendant claims that this procedure constituted an unlawful search.

“It is ... basic constitutional doctrine that both the federal and state bill of rights were *adopted to protect individuals against actions of the state.*” Southcenter Joint Venture v. Nat’l Democratic Policy Comm., 113 Wn.2d 413, 422, 780 P.2d 1282 (1989) (court’s emphasis). This “state action” requirement is “a fundamental fact of our political order.” Id. at 430. The requirement applies equally to both the Fourth Amendment and article 1, section 7. “[U]nless the person conducting the [search] is a state actor, no violation of these constitutional provisions occurs.” City of Pasco v. Shaw, 161 Wn.2d 450, 459 ¶ 16, 166 P.3d 1157 (2007).

Cases applying this doctrine reflect a confusion of terminology. A search that does not involve state action has sometimes been called a “private search.” See, e.g., State v. Smith, 110 Wn.2d 658, 666, 756 P.2d 722 (1968). Some cases have, however, recognized a distinct rule: “When the results of a private search are turned over to the State, a search that does not exceed the scope of the prior private search does not violate constitutional prohibitions.” State v. Clark, 48 Wn. App. 850, 857-58, 743 P.2d 822, review denied, 109 Wn.2d 1015 (1987). This

second rule has been called the “private search doctrine.” State v. Eisfeldt, 163 Wn.2d 628, 636, 185 P.2d 580 (2008).

In Eisfeldt, the Supreme Court rejected the latter version of the “private search doctrine.” The court held that under article 1, section 7, “the individual’s privacy interest is not extinguished simply because a private actor has actually intruded upon, or is likely to intrude upon, the interest.” Id. at 638 ¶ 16 (footnotes omitted). The court emphasized, however, that it was *not* altering the “state action” requirement:

The concurrence suggests citizens do not retain a privacy interest in evidence of a crime obtained by a private actor and delivered to the police. This is correct where the evidence obtained during a private search is given to the State; constitutional protections do not apply to private actors. But here the evidence obtained during the private search consisted entirely of [the private citizen’s] observations. The private search is not at issue here, but instead whether the private search doctrine allows the State to conduct a subsequent warrantless search. As such, the concurrence’s analysis is misplaced insofar as it compares evidence obtained by a private actor to evidence obtained by the State.

Id. n. 9.

Thus, Eisfeldt does not change fundamental constitutional analysis. Article 1, section 7 applies only to state actions. “Private

searches” – those that are not carried out by government agents – do not violate the constitution.

**2. When A Private Citizen Volunteers Unsought Information In Response To A Valid Search Warrant, That Conduct Does Not Constitute State Action.**

“In order to prove that a private individual was acting as a government agent, it must be shown that the State in some way instigated encouraged, counseled, directed, or controlled the conduct of the private person.” State v. Smith, 110 Wn.2d 658, 666, 756 P.2d 722 (1988). The defendant bears the burden of proving that a search was state action. State v. Krajieski, 104 Wn. App. 377, 382, 16 P.3d 69, review denied, 144 Wn.2d 1002 (2001).

Critical factors in determining whether a private person acts as a government agent include [1] whether the government knew of and acquiesced in the intrusive conduct and [2] whether the party performing the search intended to assist law enforcement efforts or to further his or her own ends.

State v. Swenson, 104 Wn. App. 744, 754, 9 P.3d 933 (2000).

Unless *both* questions are answered in the affirmative, the actions of the citizen are not attributed to the government. Mere knowledge that a person might conduct an illegal search is insufficient to turn the private search into a governmental one. Id. at 754-55. A person does not become a government agent simply because the police ask him for information, if the police did not

“encourage [the citizen], either expressly or tacitly, to undertake action that the police themselves could not.” State v. Clark, 48 Wn. App. 850, 856-57, 743 P.2d 822, review denied, 109 Wn.2d 1015 (1987).

Here, police obtained a valid search warrant for the defendant’s text messages. They properly submitted the warrant to the business that had possession of those messages. According to an unchallenged factual finding, they did nothing to direct the business in any way to send records outside the scope of the warrant. 1 CP 41-43, finding no. 4. Sending additional documents was solely the company’s own decision. Since police never encouraged the company to do anything that would be improper for the police themselves, the disclosure of the additional documents did not involve governmental action. Under Eisfeldt, police are entitled to use information that is furnished by a private actor without governmental involvement.

The defendant seeks to analogize the situation in this case to “a private citizen delivering a locked container belonging to another to law enforcement.” Brief of Appellant at 24. This analogy ignores a critical fact: the police had a search warrant for the putative contents of the “container.” Police who are serving a

search warrant may search items found on the scene that are plausible repositories for the objects named in the warrant. State v. Hill, 123 Wn.2d 641, 643, 870 P.2d 313 (1994). They do not need another warrant to open such items, even if they are locked. State v. Llamas-Villa, 67 Wn. App. 448, 454, 836 P.2d 239 (1992).

The true analogy for the situation in the present case is this: Police are serving a search warrant for specified business records. The business owner tells them that the records are located in a particular locked filing cabinet. He hands the officers the key. The officers unlock the cabinet and look through the contents. They find the records named in the warrant, but they also find additional records that have evidential value. They use these observations as the basis for another search warrant. Does this action violate the constitution?

The answer is clearly “no.” Because the filing cabinet is a plausible repository for the items sought, police can open it. They do not need another search warrant to do so. Once they discover incriminatory documents during the course of a lawful search, they are entitled to use the information in them to obtain another warrant. Indeed, they can even seize the documents without a new

warrant. See State v. Terrovona, 105 Wn.2d 632, 648, 716 P.2d 295 (1986).

The situation in the present case is essentially the same as this hypothetical situation. Police served a valid search warrant. They asked for nothing beyond what was covered by the warrant. The subject of the warrant gave them some documents that purported to be those covered by the warrant. The police were therefore entitled to examine those documents. The information in the documents was properly used to obtain an additional warrant. The fruits of the second warrant were therefore properly introduced into evidence.

The trial court also relied on a second basis for admitting the evidence – that it would have been inevitably discovered via the subpoena. In view of the analysis above, it is not necessary to determine the validity of this alternative basis.

**B. THE TRIAL COURT PROPERLY EXERCISED ITS DISCRETION IN ADMITTING COMPUTERIZED RECORDS THAT WERE MADE IN THE ORDINARY COURSE OF BUSINESS.**

**1. The Court Correctly Determined That The Circumstances Established The Reliability Of The Evidence.**

The defendant claims that evidence of her text messages were improperly admitted. The admissibility of business records is

governed by the Uniform Business Records as Evidence Act, RCW

5.45.020:

A record of an act, condition or event, shall in so far as relevant, be competent evidence if the custodian or other qualified witness testifies to its identity and the mode or its preparation, and if it was made in the regular course of business, at or near the time of the act, condition or event, and if, in the opinion of the court, the sources of information, method and time of preparation were such as to justify its admission.

These requirements apply equally to computer records. The trial court's decision to admit such records will not be reversed absent a manifest abuse of discretion. State v. Ben-Neth, 34 Wn. App. 600, 603, 663 P.2d 156 (1983).

In this case, a records custodian testified to the authenticity of the records and their mode of preparation. The messages were automatically recorded by their computer system and downloaded when needed. 2 RP 141-45, 149. The witness testified that these records were "the lifeline of [their] business." They had to "ensure that the integrity and accuracy of those records are kept at 100 percent level so we can bill our customers accurately and properly." 2 RP 141-45.

The trial court carefully considered the admissibility of the records. When the issue was raised pre-trial, the court refused to

admit them without additional evidence of reliability. 1 RP 75-76. The court then heard testimony from the custodian concerning the nature, source, and preparation of the records. 2 RP 140-90. After considering this testimony, the court determined that the witness was qualified and that the facts supported the accuracy of the records. 3 RP 234-38. This ruling was not an abuse of discretion.

The defendant argues that the admissibility of computerized records raises “unique issues” that require special safeguards.” Brief of Appellant at 43. Washington courts have consistently rejected this position. “If the statutory requisites are met, computerized records are treated the same as any other business records.” State v. Quincy, 122 Wn. App. 395, 399, 95 P.3d 353 (2004), review denied, 153 Wn.2d 1028 (2005).

There is no requirement that the authenticating witness be a computer expert. This court has rejected the contention that authenticating witnesses were unqualified because they “neither created or supervised creation of the computer records, understood how the records were assembled at the computer center, or had ever been to the computer center.” Because the witnesses were familiar with the business's record keeping procedures and knew how to retrieve records from the computer, they were adequately

qualified to authenticate the records. Ben-Neth, 34 Wn. App. at 604-05. A “qualified witness” need not be a computer programmer. United States v. Linn, 880 F.2d 209, 216 (9<sup>th</sup> Cir. 1989). “[Q]uestions regarding the accuracy of business records go to the weight of the evidence rather than its admissibility.” State v. Fleming, \_\_\_ Wn. App. \_\_\_, 228 P.3d 804, 809-10 (2010).

The defendant cites In re Vinhnee, 336 B.R. 437 (9<sup>th</sup> Cir. BAP 2005).<sup>3</sup> There, a Bankruptcy Appellate Panel upheld a Bankruptcy Judge’s decision to exclude computer records, based on an inadequate foundation. The Panel pointed out that admissibility of this evidence was within the discretion of the trial court. Consequently, that trial court’s decision had to be sustained unless the Panel had “the firm and definite conviction that there was a clear error of judgment in rejecting the proffered authentication.” Id. at 443. Applying this standard, the panel concluded that there was no abuse of discretion. In the present case, in contrast, the trial judge admitted the evidence. That

<sup>3</sup> The appellant’s brief refers to this as a decision of the “Ninth Circuit.” A Bankruptcy Appellate Panel is composed of Bankruptcy Judges, not Circuit Judges. The panel hears appeals that would otherwise be decided by a district court. 28 U.S.C § 158(b)(1).

decision must equally be upheld unless it constituted an abuse of discretion. Vinhnee does not demonstrate that the trial court in the present case abused its discretion in admitting the evidence.

**2. The Due Process Clause Is Not Violated By Admission Of Evidence That Is Sufficiently Reliable To Be Admissible As A Business Record.**

The defendant claims that she has a Due Process right to the exclusion of “unreliable” evidence. Whether evidence is sufficiently reliable to be admissible is governed by evidentiary rules, not by the Due Process Clause. “The aim of the requirement of due process is not to exclude presumptively false evidence, but to prevent fundamental unfairness in the use of evidence, whether true or false.” Colorado v. Connelly, 479 U.S. 157, 166, 107 S. Ct. 515, 93 L. Ed. 2d 473 (1986); see State v. McCullough, 56 Wn. App. 655, 658, 784 P.2d 566, review denied, 114 Wn.2d 1025 (1990).

The cases that the defendant cites are consistent with this principle. Both *authorize* evidentiary rules that exclude unreliable evidence offered by the *defense*. Chambers v. Mississippi, 410 U.S. 284, 302, 93 S. Ct. 1038, 34 L. Ed. 2d 297 (1973); State v. Ahflinger, 50 Wn. App. 466, 472-73, 749 P.2d 190, review denied, 110 Wn.2d 1035 (1988), Neither case *requires* the exclusion of

evidence that is sufficiently reliable to satisfy evidentiary rules. Because the evidence here was sufficiently reliable to satisfy the business records statute, it was also sufficiently reliable to satisfy Due Process.

In any event, the evidence here fully supported the reliability of the business records. During the investigation, the defendant voluntarily turned her phone over to the police. 3 RP 290-91. Messages recorded in the phone's memory were also contained in the Verizon records. The company records sometimes truncated portions of the messages, but otherwise the messages were accurately set out in the records. 6 RP 816-23.

Other evidence likewise corroborated the records. For example, the Verizon records show a message from the defendant to Starr on June 25: "I can buy oleander seeds on ebay but won't get here til next week." Ex. 3, msg. 6/25/08 11:54:49. An examination of the defendant's computer at work showed that, on the same day, she searched eBay for oleander plants. 6 RP 711. The Verizon records show a text from Starr to the defendant: "see if there is anything like most deadliest plants of Washington." Ex. 3, message 6/25/08 13:32:26. Ten minutes after this message was sent, the defendant queried Google on her work computer for

“deadliest plants in Washington State.” 6 RP 708. The evidence as a whole clearly shows that the Verizon records were reliable. Their admission did not violate Due Process.

**IV. CONCLUSION**

The judgment and sentenced should be affirmed.
