#### III. Annual Requirements for Active CPGCs who Qualify for Exemption

CPGCs who work for a Certified Agency, **or** are exempt from requirements to have Errors and Omissions (E & O) Insurance are permitted to pay lower annual certification renewal fees. To qualify, for E & O Insurance exemption, a CPGC must have 25 or fewer guardianship case appointments at one time, and with less than \$500,000 total countable guardianship assets under management. (CPGC Regulation 704.3)

### VII. Annual Requirements for Certified Agencies that Qualify for Exemption

Certified Agencies that are exempt from requirements to have Errors and Omissions (E & O) Insurance are permitted to pay lower annual certification renewal fees. To qualify, an Agency must have 25 or fewer guardianship case appointments at one time, and with less than \$500,000 total countable guardianship assets under management. (CPGC Regulation 704.3)
