

How to File a Grievance (Complaint) about a Certified Professional Guardian

Who can file a grievance about a certified professional guardian?

Anyone can file a grievance about a certified professional guardian.

Do I need a lawyer to file a grievance?

No, you do not need a lawyer..

How do I file a grievance with the Certified Professional Guardian Board?

Fill out the attached Grievance Form and send it to the Certified Professional Guardian Board.

What will the Certified Professional Guardian Board do with my grievance?

1. The disciplinary committee of the Board will review the grievance to see if the Board has the authority to act and if your complaint is clear.
2. If the guardianship case is active (the incapacitated person still has a guardian), the disciplinary committee will send the grievance to the local superior court where the guardianship case is located and ask the court to review and respond to the grievance.
3. The disciplinary committee will review the court's response and decide what action, if any, to take against the guardian. The disciplinary committee will write you about the outcome. This process usually takes several months.

Where else can I complain about a guardian?

1. If you do not have an attorney,
 - Write a letter about your complaint and take it to the clerk's office at the superior court where the guardianship case is located.
 - The court may appoint a guardian ad litem to investigate, have the clerk set up a court date, or deny your request.
2. If the incapacitated person is at risk of harm, financial exploitation, or any kind of abuse, call Adult Protective Services at 1-866-END HARM (1-866-363-4276).

Where can I learn more about the rules and regulations certified professional guardians must follow?

- All guardians must follow the regulations found in [RCW 11.88](#) and [RCW 11.92](#)
- Certified Professional Guardians must also follow the Certified Professional Guardian Board's [Standards of Practice](#) (Minimum expectations about how a guardian should act)
