RECOMMEND WE NOW TAKE NO POSITION AND WITHDRAW OPPOSITION ON CURRENT VERSION OF BILL:

Whether or not to order tests, such as polygraphs, within judicial discretion  
Test for whether respondent still meets svp standards at review is clarified as from time of last commitment trial  
all evaluations, including those requested by respondent, ordered to be based on rules developed by dept—presumably to get rid of outlier evaluators—since presumably rules have to be reasonable and subject to challenge, I don't have a problem with this.

Previous problems with bill including shifting burden to respondent at review hearing and removing judicial discretion have been stricken.
