*See* 5C Wash. Prac., Evidence Law and Practice § 804.35 (6th ed.) (“In dictum, Division 2 has suggested that an independent showing is also required in a civil case. *In re Parentage of J.H.*, 112 Wash. App. 486, 49 P.3d 154 (Div. 2 2002), as amended on denial of reconsideration, (Aug. 23, 2002). The dictum is inconsistent with Rule 804 and was not necessary to the court's ultimate holding in the case. The court held that a statement by a prison inmate was inadmissible because it was not a statement against interest in the first place, without regard to the issue of trustworthiness”).
