## I. <u>IDENTITY OF MOVING PARTY AND RELIEF</u> REQUESTED

COMES NOW the petitioner, by and through the undersigned attorney of record, and upon all the files, records, and proceedings herein, moves this Court for the relief designated below.

#### II. STATEMENT OF RELIEF SOUGHT

So that the ends of justice might be served, petitioner moves the court for the entry of an order extending and

enlarging the time to file the Petition for Review.

#### III. GROUNDS FOR RELIEF SOUGHT

As grounds for and in support of this motion, petitioner avers the following:

- 1. The Court of Appeals opinion in this matter was issued on September 19, 2023. The Petition for Review was due October 19, 2023.
- 2. Per internal office procedure, counsel emailed the Petition for Review to office support staff for filing midday on October 19 for filing the same day. Counsel mistakenly emailed the wrong document for filing, and staff could not complete filing of the petition.
- 3. Counsel was notified of the error by email at 4:08 PM on the October 19, while counsel was at a child's doctor's appointment. Counsel did not return home until after the close of business on the 19<sup>th</sup>, and could not provide staff with the correct filing the same day.
  - 4. Mr. Nelson has continuously expressed his desire to

petition this Court for review, and but for counsel's error, would not have allowed the deadline for filing the petition to elapse.

- 5. Pursuant to RAP 18.8, this Court may enlarge the time within which a Petition for Review must be filed in order to serve the ends of justice. Time for a Petition for Review to be filed may be enlarged to prevent a gross miscarriage of justice. RAP 18.8(b).
- 6. Due to counsel's inadvertent error, Mr. Nelson respectfully requests a one-day extension to permit filing of the Petition for Review to prevent a gross miscarriage of justice.

  The petition is being filed simultaneously with this motion.

#### III. CONCLUSION

Counsel asks this Court to extend the time to file the Petition for Review to October 20, 2023.

This motion complies with RAP 18.17 and contains approximately 344 words.
