STATEMENT OF
ADDITIONAL
AUTHORITIES

Pursuant to RAP 10.8, the State respectfully submits the following as additional authority. This authority relates to the absence of legislative authority for a court to award good time or earned early release credits for firearm enhancements. *See* Petition for Review at 9-13.

The Legislature considered two bills this session that would authorize good time awards for weapon enhancements.

See HB 1268, 68th Leg. Reg. Sess. (Wash. 2024);¹ HB 1798, 68th Leg. Reg. Sess. (Wash. 2024).² Both bills authorize the Department of Corrections, not the courts, to grant an award of good time for weapon enhancements. Neither bill passed the House by 5:00 p.m. on February 13, 2024, and are, therefore, “dead” for this session. *See* 2024 Session Cutoff Calendar (available at <https://leg.wa.gov/legislature/Pages/cutoff.aspx> (last visited Feb. 9, 2024)).
