It will take me some time to catch up from this major gap in treatment, while I once again attend my ongoing physical therapy appointments. extra treatment for her hands and wrists surgeries and thoracic back injury. Hand writing is impossible for her and typing can only be done in short periods given her previous surgeries on her wrists.
