

To whom it may concern,

On June 19, 2013 I wrote: "I am writing this letter to inform you that I am performing a surgical procedure on Dr. Alexander Hanuska's left ankle on 7/16/2013. This procedure has a prolonged healing time and will require significant rest, strict observance on non-weight bearing and rehabilitation. I expect him to not be fully recovered for approximately 20 weeks but healing could take longer if any unforeseen complications arise. Please accommodate will Dr. Alexander Hanuska in this healing time period."

Dr. Hanuska has informed me that Dr. Tripp (his primary care physician) and Dr. Linden (his cardiologist) also wrote him separate medical orders prohibiting him to participate in any legal activities. It seems though that the courts in Washington State are ignoring these orders and forcing my patient to perform these activities. This is not an appropriate time with regard to Dr. Hanuska's health to be performing these activities as this will compromise his healing process. Currently, his bones are only partially fused and he has yet to begin physical therapy. These unforeseen circumstances are forcing me to inform you of prolonging his time through January 30, 2014 when he may be fully recovered.


