Plaintiff respectfully requests, pursuant to RAP 18.8(b)(c) an order extending the time to file plaintiff's Motion for Discretionary Review, a petition for review of the Court of Appeals decision terminating it's review COA #43172-6-II.

Plaintiff's "Motion for Discretionary Review, RAP 13.1(a)" Supreme Court No.89816-2-State of Washington v. Rex Lee Pope that was due for filing on January 16,2014, but was not recieved until January 21,2014.

This Motion is made on the grounds that:

1. The plaintiff, who is representing himself on a prose basis and is incarcerated and unfamiliar with the law and procedures, has to be transferred from the minimum

facility to the medium facility just to be able to obtain legal library access.

- 2. There is no legal library at the minimum facility, and this process takes about one week to set-up and because he suffers from "advanced Parkinson's" disease and cannot write or type as well as having to be afforded ADA assistance which requires more time and scheduling and an assistant to work with him.
- 3. This only allows plaintiff 4.5 hours per week which prevented him from completing the necessary legal research required to properly respond with plaintiff's Motion for Discretionary review pursuant to RAP 13.4(a).
- 4. Plaintiff also notes that the typed date on his Motion for Discretionary review was in fact a clerical error and that it was actually signed by him in haste without notice and that the Motion for Review was actually sent out from the prison prior to January 16, 2014.

Petitioner requests an extension of five (5) days so that his Motion for Discretionary Review that was recieved by the court on January 21,2014 will be accepted as filed timely.
