
JOINDER

Appellant Klickitat County (“County”), a defendant in the trial court proceedings and appellant in the Court of Appeals, respectfully requests that this Court (1) reverse the Court of Appeals’ denial of co-appellant and co-defendant David Brown’s motion to disqualify Plaintiffs’ counsel, Thomas Boothe, and (2) order the trial court to disqualify Boothe as to Plaintiffs’ claims against both Brown and the County. In the trial court proceedings, the County filed a joinder to Brown’s motion. Plaintiffs did not respond or object to the joinder. Likewise, the County filed its brief with the Court of Appeals, and adopted by reference the balance of arguments in Brown’s appellate brief.


