

The Trust's Charles Schwab account never appeared in any guardianship accounting. It did not appear in the Estate's inventory (Exhibit 3, CP 319-343), nor in the guardianship first annual accounting (3/08/2002), nor in the guardianship final accounting (3/10/2003), nor in the order approving Guardian's final report (Exhibit 2, CP 319 -343, on 9/5/2003).
