

### DECLARATION


I, GEOFFREY R. LAWSON DECLARES AS  
FOLLOWS:

1. I AM OVER THE AGE OF EIGHTEEN (18) YEARS  
AND ABLE TO TESTIFY IN A COURT OF LAW.
2. I AM AN INMATE INCARCERATED AT  
AIRWAY HEIGHTS CORRECTIONS CENTER (AHCC)

3. PERSONNEL WITHIN THE WASHINGTON STATE DEPARTMENT OF CORRECTIONS (D.O.C.), TO INCLUDE AHCC, HAVE A HISTORY OF INTERFERING WITH MY ACCESS TO THE COURTS BY, AMONG OTHER THINGS, CAUSING ME TO MISS CRITICAL FILING DEADLINES IN MY CRIMINAL CASES.
4. AS ONE EXAMPLE, I WAS FORCED TO SUBMIT AN INCOMPLETE STATEMENT OF ADDITIONAL GROUNDS (SAG) IN THIS CASE ON MARCH 3, 2014. AND MY SUPPLEMENTAL SAG WAS REJECTED AS UNTIMELY.
5. IN THE MOST RECENT EXAMPLE, I MISSED A NOVEMBER 10, 2014 FILING DEADLINE IN THIS SUPREME COURT OF A MOTION FOR DISCRETIONARY REVIEW OF AN INTERLOCUTORY DECISION, WHICH MOTION IS CURRENTLY PENDING REVIEW.
6. DUE TO THE CONTINUAL NATURE OF D.O.C. INTERFERENCE WITH MY ABILITY TO FILE TIMELY PLEADINGS, I HAVE REQUESTED THE FOREGOING EXTENSION OF TIME IN WHICH TO FILE MY PETITION FOR REVIEW.
