On Page 9 of the Petition, in about the middle of the first full paragraph, the following appears:


Burnside reiterates the Washington Supreme Court's precedent for conflicts methodology and analysis. *Burnside* was a car accident case.


The reference should be to *Williams*. The two sentences should read as follows:
