GROUNDS FOR REVIEW

I, William Sancomb, have received and reviewed the opening brief prepared by my attorney. Summarized below are the additional grounds for review that are not addressed in that brief. I understand the Court will review this Statement of Additional Grounds for Review when my appeal is considered on the merits.

Additional Ground 1

THE PROSECUTOR SAT IN THE HALLWAY AFTER THE MISTRIAL WITH THREE (3) BELLEVUE POLICE OFFICERS TALKING ABOUT ME AS I WAS BEING ESCORTED FROM THE COURT ROOM. SAYING: THATS HIM RIGHT THERE LETTING THEM SEE HOW I LOOK (56) THAT THEY CAN IDENTIFY ME AT THE NEXT TRIAL WHEN HE ASK THEM TO.
