GROUNDS FOR REVIEW

I, Troy A Fisher, have received and reviewed the opening brief prepared by my attorney. Summarized below are the additional grounds for review that are not addressed in that brief. I understand the Court will review this Statement of Additional Grounds for Review when my appeal is considered on the merits.

Additional Ground 1 ^{4th amendment} ^{state of washington}
_{6th amendment} _{Article 1 section 7}

They had no authority of law when they took me into custody, I was 2 tenths of a mile from my house, force me to park on my neighbors property, took dominion of my car & keys told I couldn't take my son with me, or allow us to go home or anywhere else. had no search warrant or probable cause for an arrest warrant or search warrant, the search warrants they said they had was unconstitutional, and they wouldn't allow me to see it. This is also in my CLR 7.6 & 7.8 post trial motions.

Additional Ground 2

Due Process & 6th amendment

Judge Johnson wouldn't sign my duces tecums on 3 different attempts and finally lied on record that she signed them. She also threaten me saying she can't give me a different attorney, even though the one assigned to me went on vacation for 3 weeks and would not help me do the proper procedures. Bob Yoseph would just tell me his hands are tied, and tell my friends and family I was going to die in prison.

Ineffective assistance to counsel
