Under **Rule 17.7** an aggrieved person may object to a ruling of a commissioner... I received notice March 14, 2016 that if I didn't pay a fee of \$200.00 this case would be dismissed, because some Supreme Court decision March 6, 2015; whereas the Court of Appeals honored waiver of the filing fee. My right to access the courts because of my inability to pay has been denied. It is now April 19, 2016 and I have yet to receive anything from the Supreme Court. Please correct these errors.

I was in a car accident February 17, 2016, and am unable to work under Doctor orders. (Exhibit 1). I am currently not allowed to work until May 17, 2016 where the matter will be reviewed for further Doctors discretion. I am now receiving up to \$200 a week for loss wage compensation. My rent alone is \$718.00. I receive \$196 in food stamps and am on State Medical/Apple care. The only right I have to my children is I have to pay \$198 a month in child support. I haven't seen them since March 28, 2013 and well we have to shut up about past domestic violence so under the father's dictatorship they are only allowed to call me up to 3

1 times a year. My brother died April 10, 2016 and the father never even let them call me. Get
2 real I was a stay at home mother for 11 years until his daddy's dirty good boy network prevailed.
3 He has completely isolated them, and in his care they hate me now anyways so I am not sure if it
4 matters anymore. This has been a one sided case and demands Justice from those that actually
5 have integrity and care to do right and not play those kinds of politics.

6 I am also asking all other court costs be waived and an attorney be appointed to represent the
7 best interest of the children, by representing me. This matter was brought before this court in the
8 past IN RE: KING. This court has authority to make a decision but instead suggested it over to
9 Legislation. This court also has the authority to mandate Legislation do something as per
10 evidence IN RE: MCCLEARY.

11 The only right I have to my children is the Right to pay child support. Everything else is at the
12 fathers request and his full control. The lower court under Judge Middaugh's discretion has
13 entertained the fathers sickness and she not only enables it but she also participates. There is a
14 restraining order issued until January 30, 2022 between the children and I, and almost everytime
15 I have had to file a contempt just to get the father to give me just the basic information regarding
16 the children I get threatened with jail. No justice has ever ensued and Judge Middaugh has
17 repetitively beat it in my head that she can and she will do whatever she wants. Going in front of
18 her is like dealing with my x and his family psychological/verbal abuse... but I am not going to
19 talk about it because his dad has a lot of connections in the judicial system and well you know
20 politics.


21 There was this kid named Barry Loukitas who was being bullied by some gangster kids, and he
