В. **ARGUMENT** 

The trial court erroneously believed that it could run sentences imposed on the same day consecutively under RCW 9.94A.589 without declaring an exceptional sentence. The Court was incorrect, and the State concedes error. The plain language of RCW 9.94A.589 (1)(a) precludes the sentence in this case from running consecutive to the sentence imposed in 13-1-00551-4. This case should be remanded to the trial court for

resentencing.

C. CONCLUSION

The case should be remanded for resentencing
