1. Whistleblower Laws

2. Open Public Records Laws (OPR)

These laws require absolute compliance to ensure Public Interest
Protection to Citizens throughout the United States.

Violation of those laws are not to be tolerated especially by

Elected and Appointed Public Servant Employees.

As a Public Works Code Enforcement Officer whose daily work was “Field” Work
In all kinds of weather and Building Construction sites I was assigned a Public
Works Department Vehicle and Office at the City Public Works Building with

Other public works “Field” Employees.

In 2001 a Public Works meeting was held with the workgroup at which every Workgroup employee recommended against the appointment of a Councilman as the Public Works Supervisor because that Councilman had repeatedly violated his Councilman duties and for which we had objected to.

Lester Anderson the Councilman had insisted numerous times that I Cite his Neighbor which I could not legally do, and did therefore not do.

In spite of all the objections the Mayor and City Council in Complicity with Water Manger/ Public Works Director William **(Bill) Beckman appointed Les Anderson to the Newly created job as Public Works Supervisor.**

Shortly thereafter Lester Anderson tried to get my **Office Moved** to City Hall I wrote a rebuttal letter of over 30 **pages** that proved beyond a doubt my Office Was most efficiently located where it was in the Public Works Lagoon Building. Later that year I was cut to 1/2 a day’s work and consequently 1/2 pay. No other City employee had the Certifications to do my job.

Lester Anderson was not qualified for the job and it caused hundreds of thousands Of Dollars loss to City taxpayers thereafter. A Les Anderson subordinate Employee named Rodney Sundberg who was a long time worker with John Case and Bill Beckman was caught cheating on his own water meter readings.

State Law required both the insubordinate meter reader, his Supervisor Les Anderson and Bill Beckman to have been fired as being deficient

PUBLIC SERVANTS unqualified to thereafter have Public Employment.

Neither was fired and Lester Anderson thereafter Maliciously Harassed Patricia Madden so egregiously Patricia and another Women who witnessed the abuse of Patricia Madden both had to go to Counseling.

Thereafter for over a year and a half Patricia was afraid to even talk to Lester Anderson by phone.

IN 2005 My help was sought because a letter by eight co-workers with Patricia Madden who wrote a **letter dated 6/25/2004 requesting an investigation by City Highest Management and Council Members was never investigated.**

On **2/5/15** I appeared in Superior Court with one Eyewitness to much of what occurred and 3 Sworn Declarations from Eyewitness plus mine - Jerry Fure, Erik Abrahamson, Randy Richards, and a briefcase with **Documentary Proof of what happened in City Employment situations.**

In my actions to get this properly investigated first in the City and now in the Court System I have acted in accordance with all Public Policy and given the Chance to

Prove the merit of my claim to **be reversed** as to Dismissal of all claims and denied of **Trial in a Court of Law** the Travesty of Justice involving

Public Servant Bribery and Corruption involving Abuse of Elected and Appointed Officials as well as **General Workforce City of Stanwood Employees.**

This case needs to be allowed to be tried before a Jury or Settled by Negotiation Between the parties with each party assisted by Counsel.


