(RAP 10.8)

Respondents C.L., and Simeon J. Osborn, as litigation guardian for S.L., submit the following additional authority:

*H.B.H. v. State of Washington*, \_\_ Wn.2d \_\_, 429 P.3d 484, No. 94529-2 (Nov. 1, 2018). This Court held that “the establishment of a dependency imposes essential rights and duties on the State to care for dependent children,” *id.* at ¶24, resulting in a protective “special relationship’ that imposes a duty of care to protect the plaintiff from foreseeable harm” within the meaning of *Restatement*

*(Second) Torts* §§ 315(b) and 320, *id.* at ¶¶26-30, and rejected any requirement that “physical care and custody” is a necessary predicate “to establish a special protective relationship.” *Id.* at ¶33. *See* Answer to Petition for Review 11-14 & n.2.
