
consolidate. The State's response tries, at times, to suggest that the petitions before the Court involve different issues. But even the State is compelled to admit the petitions' "issues raised are largely related." Resp. at 2. It further states that it would not oppose consolidation if review were granted. *Id.* Thus, even the State believes the cases should be considered as one by this Court.

For the reasons set forth in petitioners' motion, this Court should grant review. The legal issues in the cases are essentially identical. System/Hatfield's case is fully briefed. MacMillan-Piper's case only awaits the State's answer, now due on March 5, 2018. As the Court has set both cases for its May 1, 2018 department meetings (Clerk Carlson's February 26, 2018 letters), the Court has ample time to process both cases for the May 1 department meetings.

The Court should grant the motion to consolidate.


